



Source-Drain Diode Forward Voltage







Single Pulse Power, Junction-to-Ambient





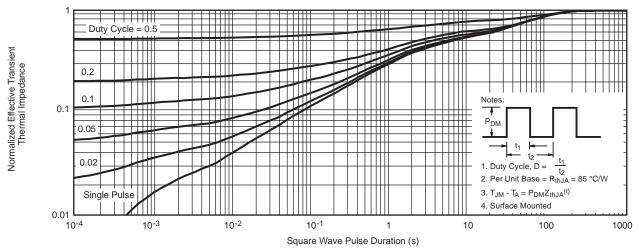



TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted




Normalized Thermal Transient Impedance, Junction-to-Ambient


