







**Transconductance** 



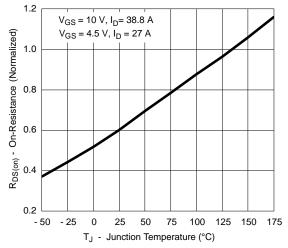


R<sub>DS(on)</sub> vs. Drain Current








On-Resistance vs. Junction Temperature




 $R_{DS(on)}\, vs. \, V_{GS}\, vs. \, Temperature$ 



Forward Diode Voltage vs. Temperature




Threshold Voltage






Normalized Thermal Transient Impedance, Junction-to-Case




