









Source-Drain Diode Forward Voltage

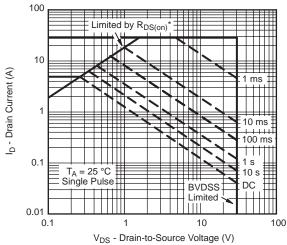


Single Pulse Power, Junction-to-Ambient








 $T_{\,C}$ - Case Temperature (°C)








T_A - Ambient Temperature (°C)




Normalized Thermal Transient Impedance, Junction-to-Ambient
