










Source-Drain Diode Forward Voltage




Threshold Voltage



On-Resistance vs. Gate-to-Source Voltage




Single Pulse Power








T_C - Case Temperature (°C)

Power, Junction-to-Foot




T_A - Ambient Temperature (°C)


