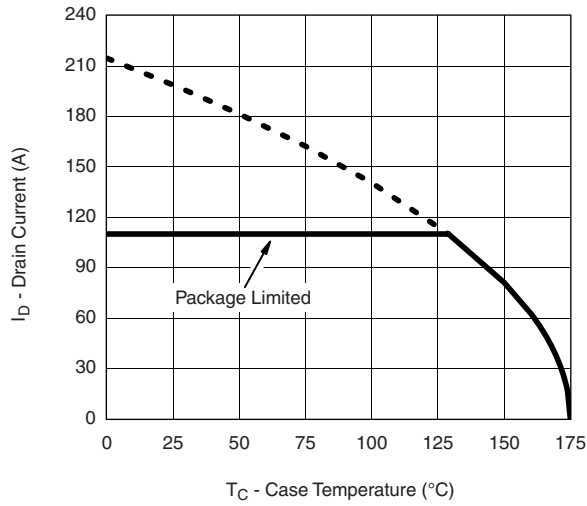

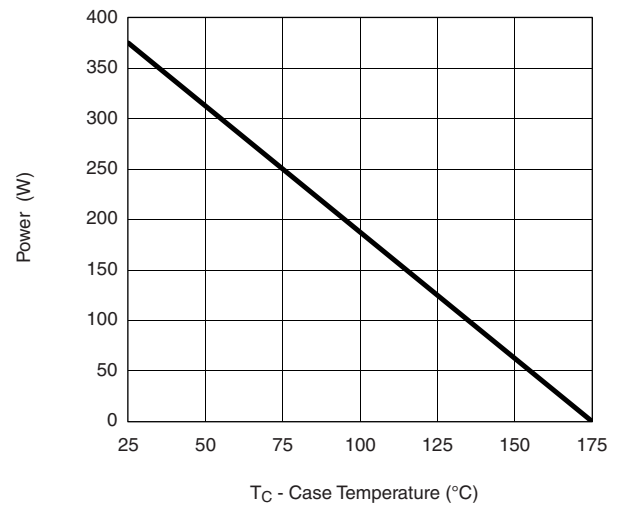

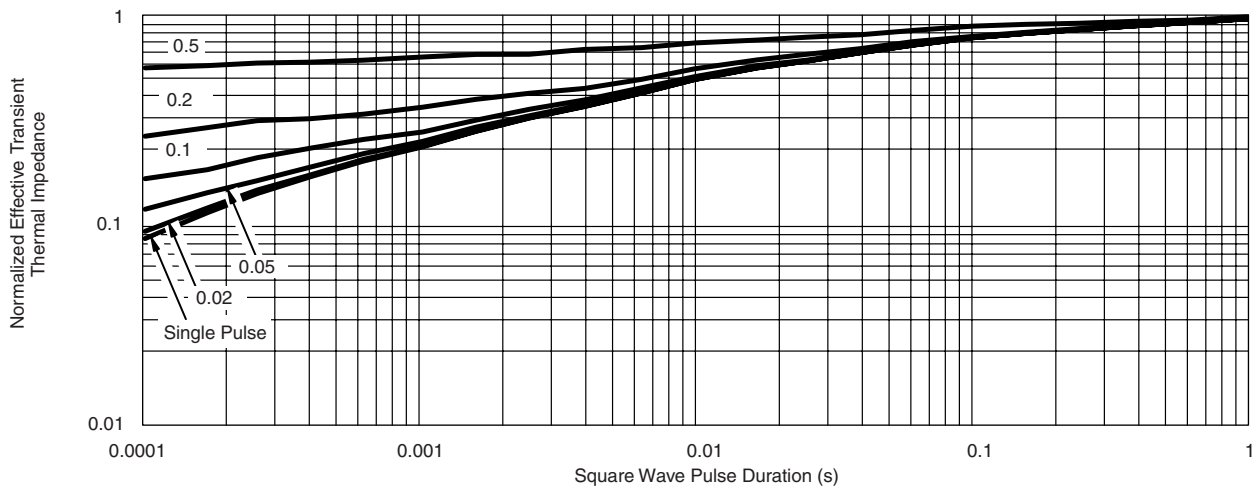

**Max. Avalanche and Drain Current vs. Case Temperature\***



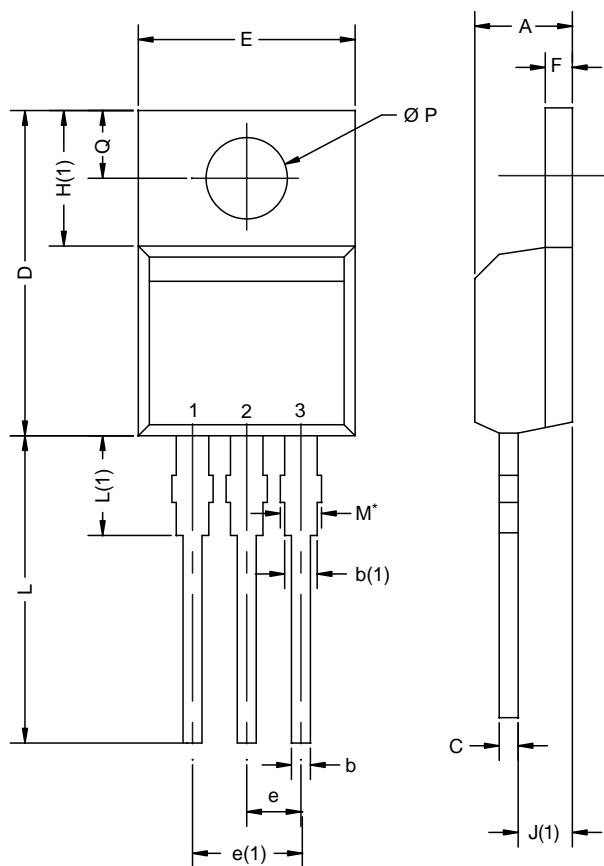
**Power Derating, Junction-to-Case**
