





Square Wave Pulse Duration (s) Normalized Thermal Transient Impedance, Junction-to-Foot 1

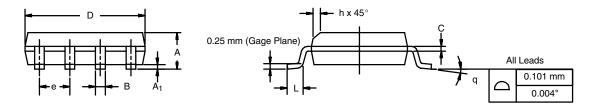

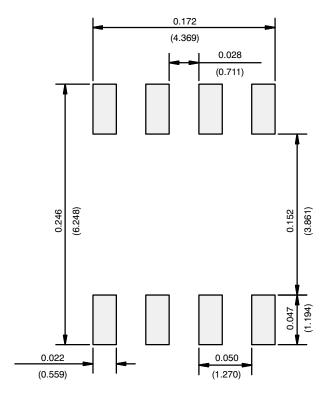
