





Gate Charge



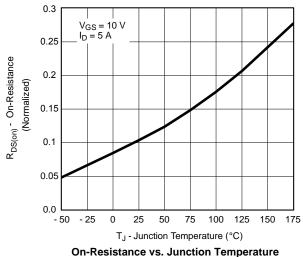




Source-Drain Diode Forward Voltage
