









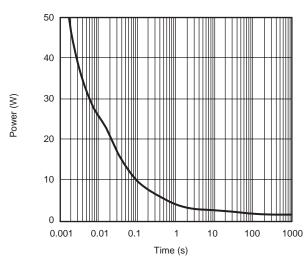
Source-Drain Diode Forward Voltage




Threshold Voltage

Single Pulse Power

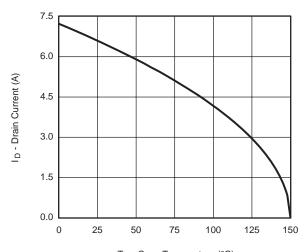








T_C - Case Temperature (°C)

Current Derating*






T_A - Ambient Temperature (°C)




