


 \mathbf{Q}_{g} - Total Gate Charge (nC) $\mathbf{Gate\ Charge}$







On-Resistance vs. Gate-to-Source Voltage




Single Pulse Power, Junction-to-Ambient









Power Derating, Junction-to-Ambient


Normalized Thermal Transient Impedance, Junction-to-Ambient





Normalized Thermal Transient Impedance, Junction-to-Foot


