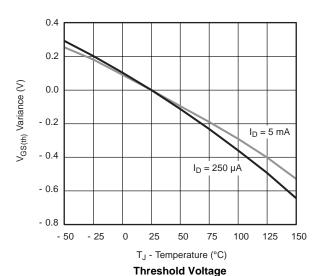








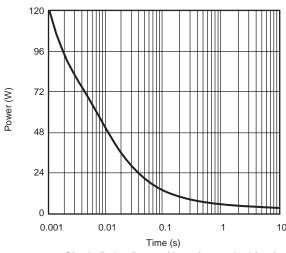
#### Source-Drain Diode Forward Voltage



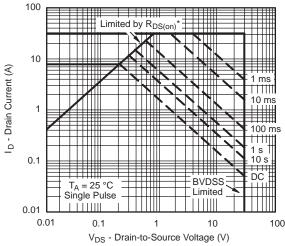

Single Pulse Power (Junction-to-Ambient)

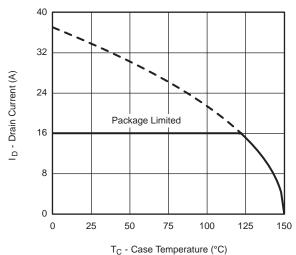

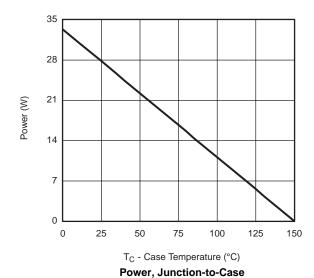

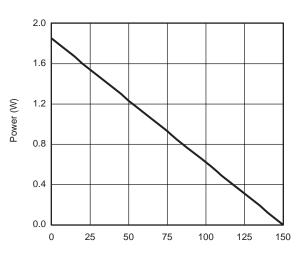

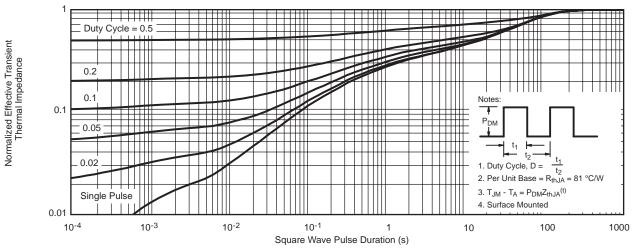


T<sub>A</sub> - Case Temperature (°C)

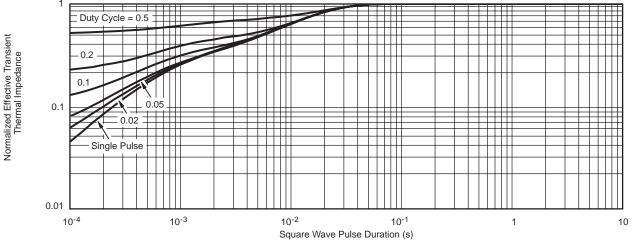

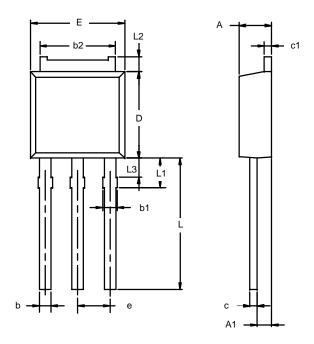
Normalized Thermal Transient Impedance, Junction-to-Ambient
