TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted




Time (s) Single Pulse Power







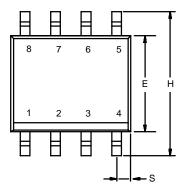


Normalized Thermal Transient Impedance, Junction-to-Foot
