









On-Resistance vs. Drain Current




On-Resistance vs. Gate-to-Source Voltage








Source-Drain Diode Forward Voltage




 $$T_{\rm J}$$ - Junction Temperature (°C) **On-Resistance vs. Junction Temperature**

Drain Source Breakdown vs. Junction Temperature








Single Pulse Avalanche Current Capability vs. Time






Normalized Thermal Transient Impedance, Junction-to-Case
