I_D - Drain Current (A)

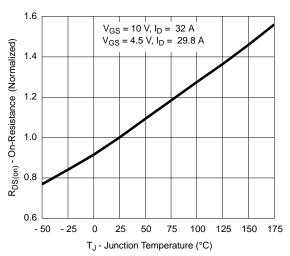
R_{DS(on)} vs. Drain Current





Normalized Thermal Transient Impedance, Junction-to-Case
