



# **TYPICAL CHARACTERISTICS** (T<sub>A</sub> = 25 °C, unless otherwise noted)






# **TYPICAL CHARACTERISTICS** ( $T_A = 25 \, ^{\circ}\text{C}$ , unless otherwise noted)







#### On-Resistance vs. Junction Temperature



**Source Drain Diode Forward Voltage** 




#### On-Resistance vs. Gate-to-Source Voltage




Drain Source Breakdown vs. Junction Temperature


Normalized Thermal Transient Impedance, Junction-to-Ambient

Normalized Thermal Transient Impedance, Junction-to-Case




